1. About this Privacy Statement

2. Personal Data

5. What Information we collect and why



The information we collect from you at this website may include the following: your name, gender, home and work contact details, business title, email address, IP address, telephone number, date of birth, nationality, payment information, purchase history and your reviews and opinions about our products and services.

1. INFORMATION PROVIDED BY YOU

If you use this website or its various applications, you may be required to provide personal information as part of registration, including but not limited to: first name, last name, company name, title, address, city, state, zip, telephone, email address, preferred method of contact (email, phone, postal), account number, service and product interest information and intended use of services or products. 2. LOG FILES
